02/26/07 Spud @ 6:00 a.m. Drill 11" surface hole to 328'. Run 10 jts. of 8 5/8", 24 #, J55 ST & C casing at 319'. Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulate 6 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

02/27/07 Drill 7 7/8" hole from 328' - 2685'. Reached TD 2685' at 4:00 a.m. MIRU Superior and log well. Logger's TD at 2656'. Run 56 jts 5 1/2", 15.5 ppg, J-55, and 10 jts 17 ppg, J-55 LT&C casing at 2573'. HES mixed and pumped 291 sks Midcon II cement. Circulated 15 bbls of cement to surface.
