04/27/07 Drill 7 7/8" hole from 333' - 2575'. Reached TD at 2575' at 7:15 a.m. MIRU Superior and log well. Logger's TD 2567'. Run 52 jts 5 1/2", 15.5 ppf, J-55, and 10 jts 17 ppf, J-55 LT& C casing at 2421'. HES mixed and pumped 370 sks Midcon II cement. No cement returns.
