01/320/08 Drill 7 7/8" hole from 333' - 2,085'. Reached TD at 2,085' at 2:00 p.m. MIRU Superior and log well. Logger's TD 2,085'. Run 45 jts 5 1/2, 15.5 ppf, J-55, and 9 jts 17 ppf, J-55 LT&C casing at 2,071'. HES mixed and pumped 262 sks Midcon II cement. Circulated 20 bbls of cement to surface.
