- 2 EXAMINER LOWE: Good morning. Today is
- 3 Thursday, October 17th, 2019. Today is Examiner Hearing
- 4 Docket Number 39-19. My name is Leonard Lowe, and I'll
- 5 be your hearing examiner for this day. With me we have
- 6 Bill Brancard, Phillip Goetze, Dean McClure, and the
- 7 rest of us here.
- 8 As of yesterday we had 85 cases on the
- 9 docket. As of this morning I will announce all the
- 10 continuances and dismissals.

- 14 should be would be continued to October 31st.
- 15 EXAMINER LOWE: Okay.
- 16 MS. MARLENE SALVIDREZ: And then
- 17 page 55 -- I mean, Number 55 on the docket page 5, 20676
- 18 October 31st.
- 19 EXAMINER LOWE: Okay. Thank you, Marlene.
- 20 On that note we will continue with -- we
- 21 will start off with --
- 22 MS. BENNETT: Mr. Examiner, I do have a
- 23 quick question on Cases Number 29 and 30 on the docket,
- 24 and I think I may have just missed those as you reading
- 25 through. My notes show that those should have been

- 1 continued.
- 2 Did you happen to read those off when you
- 3 read the continuances?
- 4 EXAMINER LOWE: Yes.
- 5 MS. BENNETT: Okay. Thank you.
- 6 MR. ADAM RANKIN: Mr. Examiner, Adam
- 7 Rankin with Holland & Hart. Mr. Examiner, on Case
- 8 Number 1 on the docket, Case Number 13987, as of
- 9 yesterday we were intending to put this case on. I got
- 10 a call from the client indicating they had found
- 11 additional parties who had not received notice. They
- 12 have been searching their ownership records since the
- 13 September 19th hearing, and they did find some
- 14 yesterday.
- 15 So, as consequence, while we were
- 16 intending to put the case on today, we have to continue
- 17 it until January 23rd so that we can perfect notice to
- 18 those additional parties. So, we filed an application
- 19 for continuance yesterday as soon as we found out, and
- 20 we ask that that case be continued to the 23rd so we can
- 21 perfect notice.
- 22 EXAMINER LOWE: Okay. We will inquire
- 23 with Marlene about that.
- 24 MR. ADAM RANKIN: Well, pursuant to the
- 25 rules -- the reason for the continuance arose after the

1 deadline. And so the rule says continuance may be filed

- 2 if the reason for the continuance comes up after the
- 3 deadline, which in this case it did.
- 4 And so we're asking that the case be
- 5 continued. It's -- nobody's prejudiced. There's no
- 6 other parties in the matter. And so I think it makes
- 7 sense. It's more efficient to just continue the case
- 8 and perfect notice and present the affidavit on the 23rd
- 9 of January.
- 10 EXAMINER LOWE: Okay. We'll try to work
- 11 on that on our side.
- MR. ADAM RANKIN: Okay. Thank you.
- 13 EXAMINER GOETZE: Just a comment. And it
- 14 wasn't until yesterday that we still did not have
- 15 information of notice?
- 16 MR. ADAM RANKIN: That is correct.
- 17 EXAMINER GOETZE: And these are the land
- 18 people?
- 19 MR. ADAM RANKIN: Yes, that is correct.
- 20 EXAMINER GOETZE: Okay. Well, just
- 21 they've been working on this since September.
- 22 MR. ADAM RANKIN: I understand. I agree.
- 23 I agree.
- 24 EXAMINER GOETZE: Okay. Just so noted.
- 25 EXAMINER LOWE: Okay. Do you have any
