APPLICATION

COG Operating LLC (“COG”) (OGRID No. 229137), through its undersigned attorneys, hereby files this application with the Oil Conservation Division (“Division”) for the limited purpose of pooling additional interest owners under the terms of Division Order No. R-21476 (“Order”). In support of its application, COG states:

1. The Division entered the Order in Case No. 21424 on September 25, 2020, which created a 1280-acre, more or less, standard horizontal spacing unit comprised of all of Sections 17 and 20, Township 24 South, Range 28 East, Eddy County, New Mexico (“Unit”), and designated COG as the operator of the Unit.
2. The Order further pooled all uncommitted interests within the Purple Sage Wolfcamp Gas Pool (Pool Code: 98220) underlying the Unit and dedicated the Unit to the Tomahawk WC Unit #709H, 710H, 711H, 712H, and 713H wells.
3. COG has identified additional mineral interest owners in the Unit that have not been pooled under the terms of the Order.

4. In order to permit COG to obtain its just and fair share of the oil and gas underlying the subject lands, COG requests that the Order be opened for the limited purpose of pooling the additional mineral interest owners in the Unit pursuant to the terms within the Order.

WHEREFORE, COG requests that this application be set for hearing before an Examiner of the Oil Conservation Division on March 4, 2021, and after notice and hearing as required by law, the Division pool the additional interest owners pursuant to the terms of the Order.
