APPLICANT’S STATEMENT OF CASES

In Case No. 21924, Devon seeks an order (1) creating a standard 399.88-acre, more or less, spacing and proration unit comprised of the W/2 E/2 of Section 5, the W/2 E/2 of Section 8, and the W/2 NE/4 of Section 17, Township 23 South, Range 31 East, NMPM, Eddy County, New Mexico, and (2) pooling all uncommitted mineral interests in the Bone Spring formation, designated as an oil pool, underlying said unit.

In Case No. 21925, Devon seeks an order (1) creating a standard 399.82-acre, more or less, spacing and proration unit comprised of the E/2 E/2 of Section 5, the E/2 E/2 of Section 8, and the E/2 NE/4 of Section 17, Township 23 South, Range 31 East, NMPM, Eddy County, New Mexico, and (2) pooling all uncommitted mineral interests in the Bone Spring formation, designated as an oil pool, underlying said unit.

Devon proposes to dedicate the units to its **Fiji 17-5 Fed Com 233H Well**, for Case No. 21954, and to its **Fiji 17-5 Fed Com 234H Well**, for Case No. 21925. The 233H Well is proposed to be horizontally drilled from a surface location in SW/4 NE/4 (Unit G) of Section 17 to a bottom hole location in Lot 2 (NW/4 NE/4) of Section 5. The 234H is proposed to be horizontally drilled from a surface location in SE/4 NE/4 (Unit H) of Section 17 to a bottom hole location in Lot 1 (NE/4 NE/4) of Section 5.
