**MOTION TO CONSOLIDATE AND TO CONTINUE TO AUGUST 6, 2021**

ConocoPhillips moves to continue the above-referenced competing compulsory pooling cases to the **August 6, 2021** contested hearing with the following cases: Case Nos. 21927, 21929 and 21931 (Spur Energy Partners) and Case Nos. 21997, 21998 and 21999 (ConocoPhillips Company), which are currently consolidated and subject to a Prehearing Order, date June 7, 2021. A continuance will allow all the parties' competing compulsory pooling cases to be heard together and will thereby promote administrative efficiency.

For the same reasons, ConocoPhillips further moves to consolidate Case Nos. 21926, 21928, 22027, and 22028 with Case Nos. 21927, 21929 and 21931 and Case Nos. 21997, 21998 and 21999 under the same Prehearing Order.

Spur Energy Partners and Chevron USA Inc. do not oppose the requested continuance and consolidation, but no response was received from counsel for Yates Holdings at the time of filing.
