**UNOPPOSED MOTION FOR CONTINUANCE  
AND AMENDED PRE-HEARING ORDER**

Spur Energy Partners, LLC (“Spur”) requests a continuance of these matters to the Oil Conservation Division’s (“Division”) September 9, 2021 hearing docket and an amended pre-hearing order reflecting the revised hearing date. In support of its motion, Spur states the following.

1. The above-referenced applications are set for a contested hearing on the Division’s July 15, 2021 hearing docket.
2. Contango Oil & Gas Company (“Contango”) opposes Spur’s applications, citing concerns that Spur’s hydraulic fracturing operations previously impacted one of Contango’s vertical wells in unrelated acreage.
3. There is good cause for a continuance to the Division’s September 9, 2021 hearing docket, as the parties require additional time to determine whether these matters can be resolved.
4. In addition, Contango opposes Longfellow Energy, LP’s (“Longfellow”) compulsory pooling application in Case No. 21860 based on the same concerns and event.
5. On June 22, 2021, the Division entered a pre-hearing order setting Case No. 21860 for a contested hearing on September 9, 2021.
6. Since Contango’s basis for opposition is the same in Longfellow’s Case No. 21860 and Spur’s Case Nos. 21935 and 21936, it would promote administrative economy and conserve resources for these matters to be heard on the same hearing date.

7. No party of record opposes this motion.

WHEREFORE, Spur requests the Division grant its motion to continue Case Nos. 21935 and 21936 to the September 9, 2021 hearing docket and for an amended pre-hearing order reflecting the revised hearing date.
