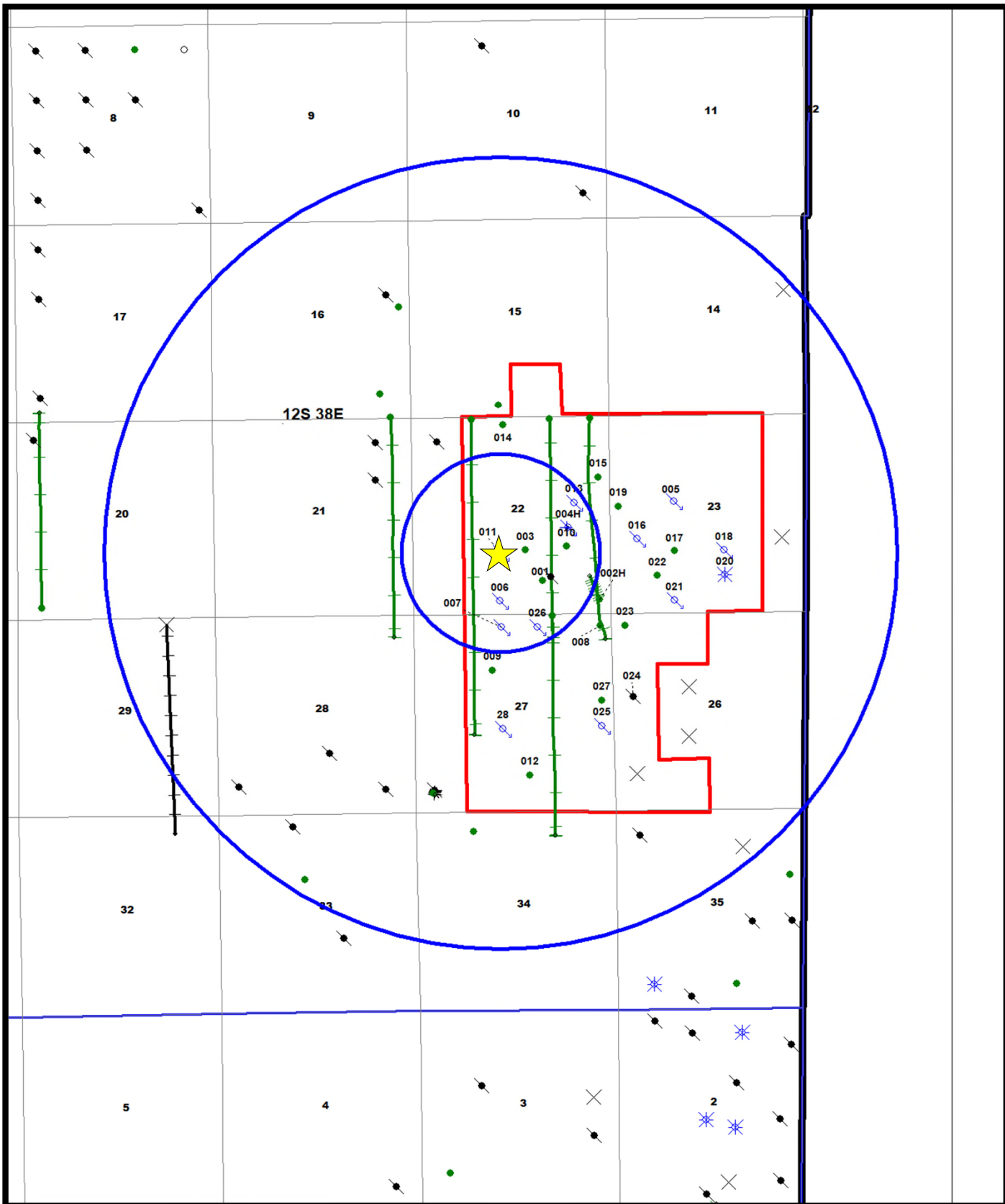

TBAU #4H – Well History

The Trinity Burrus Abo Unit #4H – API # 30-025-35817 – was originally drilled in 2002 as the vertical Burrus #4 by Rick's Exploration Inc. The well was completed as a producer with Wolfcamp perforations from 9,050'-9,078'.

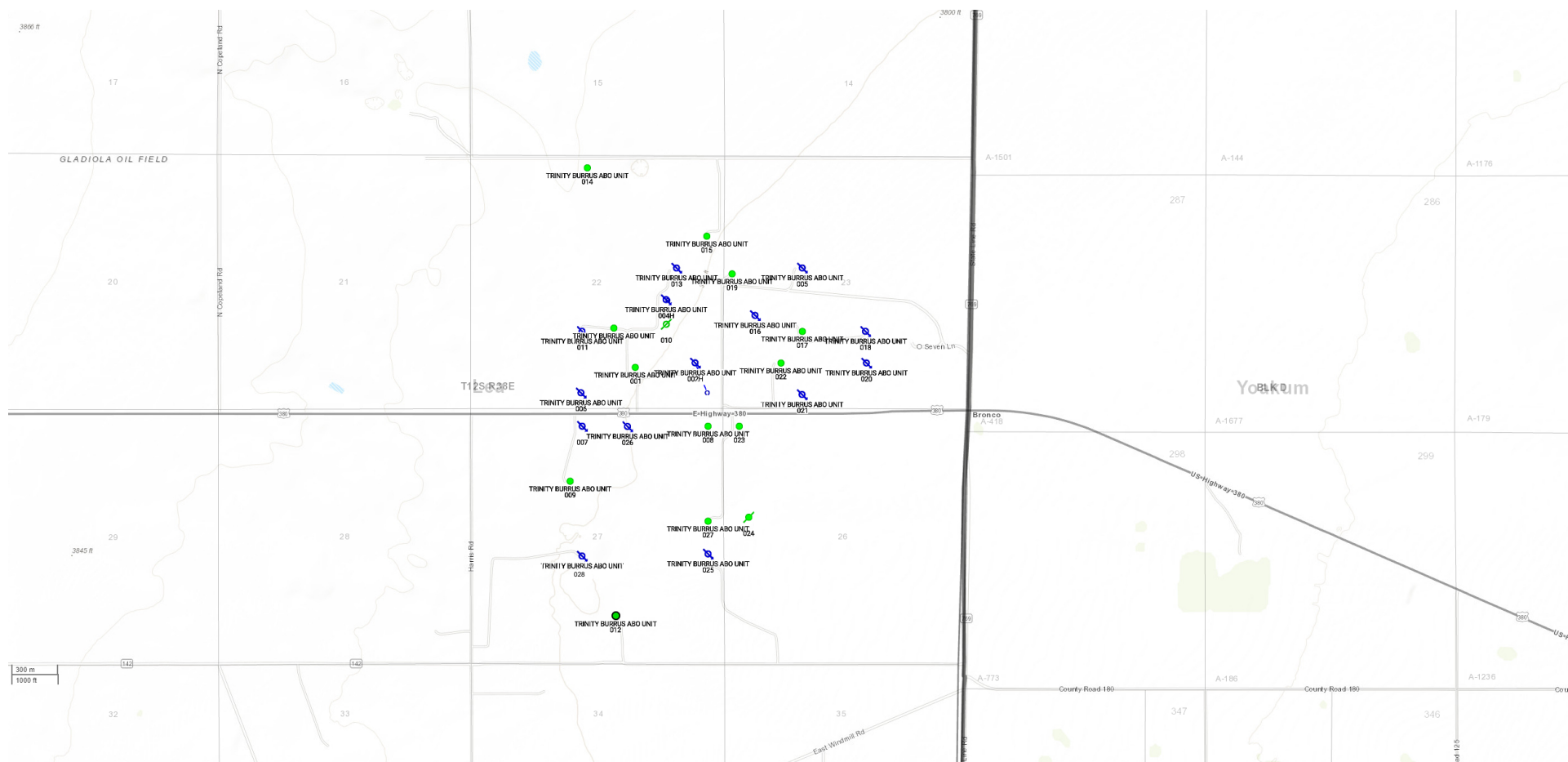
Chesapeake became operator of record for this well in 2004, and when the waterflood was unitized in 2006, the well was re-named the Trinity Burrus Abo Unit #4. In 2007 it was discovered that the 5.5" production casing had collapsed, just above TOC at a depth of 7,286'. Chesapeake proceeded with work to remedy the situation and decided to convert the well to an injector. Based on notes in the well file, the reasoning was the lack of other injectors in the area and the low oil production rate achieved from the original wellbore. The production casing was chemically cut at a depth of 5,150' and pulled from the well.

A 450 sack cement kickoff plug was pumped and the well was kicked off directionally at 4,586'. Chesapeake then sidetracked around the originally wellbore to a depth of 8,573', where they began to build the curve. Horizontal was achieved at a depth near 9,371', according to surveys, from which the well was drilled to a measured depth of 10,015' or a vertical section of 1,234.49' in the direction of 149.71° (SE of SL). 5.5" casing was run to bottom in the new wellbore and cemented in place with 380 sacks class H cement.

Pre-perforated production casing was run in the 5.5" string from 9,360'-10,015', and this interval was subsequently acidized. 2 3/8" coated injection tubing and packer were then run in the well and it was put on injection. The well has remained an injector since this work was completed.

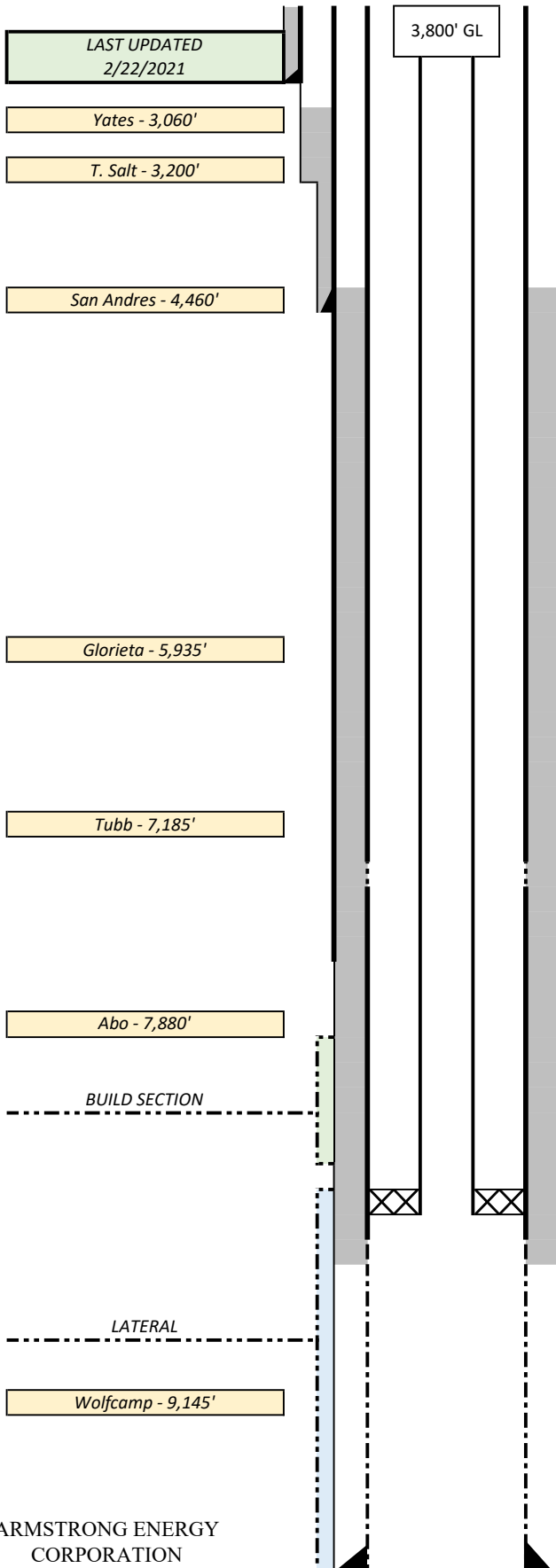
