
**UNOPPOSED MOTION  
TO VACATE PRE-HEARING ORDER  
AND TO CONSOLIDATE CASES FOR HEARING**

Caza Petroleum, LLC and Caza Operating, LLC move the Division for an order vacating the pre-hearing order in these cases, and in support thereof, state:

1. Chisholm Energy Operating, LLC opposes the applications because it operates a portion of the acreage sought to be pooled by Applicants.
2. Case No. 21565 is set for hearing (under a pre-hearing order dated April 23, 2021) on August 19, 2021.
3. The parties and the Division have verbally approved, for purposes of hearing, a consolidation of Case No. 22048 with Case No. 21565. Applicants hereby formally move the Division for an order consolidating the two cases.
4. The parties are discussing settlement of their differences, and do not believe it would be productive to have a contested hearing at this time.
5. As a result, Applicants request that the pre-hearing order be vacated.
6. The parties request that these cases be set as a status conference on the August 19, 2021 docket.
