STATEMENT OF THE CASE

APPLICANT

Case No. 22208: Tap Rock Resources, LLC seeks an order pooling all mineral interest owners in the Bone Spring formation underlying a horizontal spacing unit comprised of the W/2W/2 of Section 16 and the W/2W/2 of Section 21, Township 26 South, Range 35 East, NMPM, Lea County, New Mexico. The unit will be dedicated to the Talco State Fed. Com. Well No. 111H, which has a first take point in the NW/4NW/4 of Section 16 and a last take point in the SW/4SW/4 of Section 21.

Case No. 22209: Tap Rock Resources, LLC seeks an order pooling all mineral interest owners in the Bone Spring formation underlying a horizontal spacing unit comprised of the E/2W/2 of Section 16 and the E/2W/2 of Section 21, Township 26 South, Range 35 East, NMPM, Lea County, New Mexico. The unit will be dedicated to the Talco State Fed. Com. Well No. 112H, which has a first take point in the NE/4NW/4 of Section 16 and a last take point in the SE/4SW/4 of Section 21.

Also to be considered in each case will be the cost of drilling and completing the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of Tap Rock Operating, LLC as operator of the wells, and a 200% charge for the risk involved in drilling, completing, and equipping the wells.


