**JOINT MOTION TO VACATE PRE-HEARING ORDER  
AND FOR STATUS CONFERENCE**

Spur Energy Partners, LLC (“Spur”) and ConocoPhillips Company (“COPC”) (collectively the “Parties”) request that the Division: (1) enter an order vacating the amended pre-hearing order and hearing date in the above-referenced cases; and (2) set these matters for a status conference on the December 16, 2021 hearing docket. In support of this motion, the Parties state the following.

1. In these cases, the Parties have filed competing applications that seek orders pooling all mineral interests in certain acreage in Lea County, New Mexico.
2. On August 5, 2021, The Division entered an amended pre-hearing order setting these cases for hearing on November 4, 2021.
3. The Parties are involved in negotiations and do not believe it would be productive to have a contested hearing at this time. As a result, they request that the Division vacate the amended pre-hearing order and set these cases for a status conference on December 16, 2021.
4. Counsel for COPC approves of this motion.

WHEREFORE, the Parties request the amended pre-hearing order and hearing date be vacated and the above-referenced cases be scheduled for a status conference on the December 16, 2021 hearing docket.
