The unit will be dedicated to the Michael K&B 2122 Fed. Com. Well No. 121H, with a first take point in the NW/4NW/4 of Section 21 and a last take point in the NE/4NE/4 of Section 22.

The unit will be dedicated to the Michael K&B 2122 Fed. Com. Well No. 202H, with a first take point in the SW/4NW/4 of Section 21 and a last take point in the SE/4NE/4 of Section 22.

Also to be considered will be the cost of drilling, completing, and equipping the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling, completing, and equipping the wells.
