STATEMENT OF THE CASE

Applicant applies for an order pooling all uncommitted mineral interests within the San Andres formation underlying a 160-acre, more or less, standard horizontal spacing unit comprised of the W/2E/2 of Section 22, Township 13 South, Range 38 East, Lea County, New Mexico (“Unit”). The Unit will be dedicated to the following proposed initial well: Combo Fee #2H to be horizontally drilled from a surface hole location in the SW/4SE/4 (Unit O) of Section 15 to a

bottom hole location in the SW/4SE/4 (Unit O) of Section 22 (“Well”). The completed interval of the Well will be unorthodox.

Also to be considered will be the cost of drilling and completing the Well and the allocation of the costs, the designation of Applicant as the operator of the Well, and a 200% charge for the risk involved in drilling and completing the Well. The Well is located approximately 14.5 miles Southeast of Tatum, New Mexico.
