operator of the horizontal spacing unit for the drilling of Colgate’s proposed **Dakota 32 State Fed Com 123H** and **Dakota 32 State Fed Com 133H** wells, and pooled uncommitted interest owners in a 320-acre (more or less) Bone Spring spacing unit underlying the N/2 S/2 of Section 32 and N/2 S/2 of Section 31, Township 19 South, Range 28 East, NMPM, Eddy County, New Mexico. Said area is located approximately 19 miles southeast of Artesia, New Mexico.

In Case No. 22311, Colgate seeks an order from the Division for the limited purposes of amending Order No. R-21495 to allow for an extension of time for drilling the wells under Order No. R-21495.
