STATEMENT OF THE CASE

APPLICANT

Case No. 22336: Mewbourne Oil Company seeks an order pooling all mineral interest owners in the Bone Spring formation in a horizontal spacing unit comprised of the N/2SE/4 of Section 3 and the N/2S/2 of Section 2, Township 18 South, Range 29 East, NMPM. The unit will be dedicated to the Swanson 3/2 B2JI Fed. Com. Well No. 1H, a horizontal well with a first take point in the NW/4SE/4 of Section 3 and a last take point in the NE/4SE/4 of Section 2.

Case No. 22337: Mewbourne Oil Company seeks an order pooling all mineral interests in the Bone Spring formation in a horizontal spacing unit comprised of the S/2SE/4 of Section 3 and the S/2S/2 of Section 2, Township 18 South, Range 29 East, NMPM. The unit will be dedicated to the Swanson 3/2 B2OP Fed. Com. Well No. 1H, a horizontal well with a first take point in the SW/4SE/4 of Section 3 and a last take point in the SE/4SE/4 of Section 2.

Also to be considered will be the cost of drilling, completing, and equipping the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling, completing, and equipping the wells.
