STATEMENT OF THE CASE

In **Case No. 22369**, Applicant applies for an order pooling all uncommitted interests within the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2E/2 of Sections 5 and 8, Township 26 South, Range 29 East, Eddy County, New Mexico (“Unit”). The Unit will be dedicated to the Hambone #501H well to be horizontally drilled from a surface hole location in the SE/4SE/4 (Unit P) of Section 8 to a bottom hole location in the NE/4NE/4 (Unit A) of Section 5. Also to be considered will be the cost of drilling and

completing the Well and the allocation of the costs, the designation of Applicant as the operator of the Well, and a 200% charge for the risk involved in drilling and completing the Well.

In **Case No. 22370**, Applicant applies for an order pooling all uncommitted interests within the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2E/2 of Sections 5 and 8, Township 26 South, Range 29 East, Eddy County, New Mexico (“Unit”). The Unit will be dedicated to the Hambone #502H well to be horizontally drilled from a surface hole location in the SW/4SE/4 (Unit O) of Section 8 to a bottom hole location in the NW/4NE/4 (Unit B) of Section 5. Also to be considered will be the cost of drilling and completing the Well and the allocation of the costs, the designation of Applicant as the operator of the Well, and a 200% charge for the risk involved in drilling and completing the Well.

In **Case No. 22371**, Applicant applies for an order pooling all uncommitted interests within the Bone Spring formation underlying a 280-acre, more or less, standard horizontal spacing unit comprised of the E/2W/2 of Section 5, the E/2NW/4 and NE/4SW/4 of 8, Township 26 South, Range 29 East, Eddy County, New Mexico (“Unit”). The Unit will be dedicated to the Hambone #505H well to be horizontally drilled from a surface hole location in the NE/4SW/4 (Unit K) of Section 8 to a bottom hole location in the NE/4NW/4 (Unit C) of Section 5. Also to be considered will be the cost of drilling and completing the Well and the allocation of the costs, the designation of Applicant as the operator of the Well, and a 200% charge for the risk involved in drilling and completing the Well.

In **Case No. 22372**, Applicant applies for an order pooling all uncommitted interests within the Bone Spring formation underlying a 280-acre, more or less, standard horizontal spacing unit comprised of the W/2W/2 of Section 5, the W/2NW/4 and NW/4SW/4 of 8, Township 26 South, Range 29 East, Eddy County, New Mexico (“Unit”). The Unit will be dedicated to the Hambone

#506H well to be horizontally drilled from a surface hole location in the NW/4SW/4 (Unit L) of Section 8 to a bottom hole location in the NW/4NW/4 (Unit D) of Section 5. Also to be considered will be the cost of drilling and completing the Well and the allocation of the costs, the designation of Applicant as the operator of the Well, and a 200% charge for the risk involved in drilling and completing the Well.

The Wells are located approximately 10.4 miles south of Malaga, New Mexico.
