**APPLICANT’S STATEMENT OF CASE**

In **Case No. 22400**, Ameredev seeks an order (1) pooling all uncommitted interest in the Bone Spring formation, in a 320-acre, more or less, standard spacing unit comprised of the E/2 W/2 of Sections 29 and 32, Township 25 South, Range 36 East, NMPM, Lea County, New Mexico; and (2) dedicating the above-referenced horizontal spacing unit to the proposed initial **Red Bud Fed Com 25 36 32 #093H well** (API No. 30-025-pending), to be horizontally drilled from

a surface location in the SE/4 SW/4 (Unit N) of Section 32 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 29. The completed interval of the well will comply with statewide setbacks for oil wells.

In **Case No. 22401**, Ameredev seeks an order (1) pooling all uncommitted interests in the Wolfcamp formation, in a 320-acre, more or less, standard spacing unit comprised of the E/2 W/2 of Sections 29 and 32, Township 25 South, Range 36 East, NMPM, Lea County, New Mexico; and (2) dedicating the above-referenced horizontal spacing unit to the proposed initial wells, both are to be horizontally drilled from a surface location in the SE/4 SW/4 (Unit N) of Section 32 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 29: (1) Red Bud Fed Com 25 36 32 #104H well (API No. 30-025-pending), and (2) Red Bud Fed Com 25 36 32 #114H well (API No. 30-025-pending). The completed interval of the wells will comply with statewide setbacks for oil wells.
