In Case No. 22417, Matador seeks an order: (1) pooling all uncommitted interests in the Bone Spring formation underlying a standard 320-acre, more or less, horizontal spacing unit comprised of the W/2 SW/4 of Section 18, the W/2 W/2 of Section 19, and the W/2 NW/4 of Section 30, Township 24 South, Range 36 East, NMPM, Lea County, New Mexico, and (2) dedicating the spacing unit to the proposed initial Lonnie King Fed Com #135H well, to be drilled

from a surface location in the SW/4 NW/4 (Unit E) of Section 30, to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 18.

In Case No. 22418, Matador seeks an order: (1) pooling all uncommitted interests in the Bone Spring formation underlying a standard 320-acre, more or less, horizontal spacing unit comprised of the E/2 SW/4 of Section 18, the E/2 W/2 of Section 19, and the E/2 NW/4 of Section 30, Township 24 South, Range 36 East, NMPM, Lea County, New Mexico, and (2) dedicating the spacing unit to the proposed initial Lonnie King Fed Com #136H well, to be drilled from a surface location in the SW/4 NW/4 (Unit E) of Section 30, to a bottom hole location in the NE/4 SW/4 (Unit K) of Section 18.

In Case No. 22419, Matador seeks an order: (1) pooling all uncommitted interests in the Wolfcamp formation underlying a standard 320-acre, more or less, horizontal spacing unit comprised of the W/2 SW/4 of Section 18, the W/2 W/2 of Section 19, and the W/2 NW/4 of Section 30, Township 24 South, Range 36 East, NMPM, Lea County, New Mexico, and (2) dedicating the spacing unit to the proposed initial Lonnie King Fed Com #211H well, to be drilled from a surface location in the SW/4 NW/4 (Unit E) of Section 30, to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 18.

In Case No. 22420, Matador seeks an order: (1) pooling all uncommitted interests in the Wolfcamp formation underlying a standard 320-acre, more or less, horizontal spacing unit comprised of the E/2 SW/4 of Section 18, the E/2 W/2 of Section 19, and the E/2 NW/4 of Section 30, Township 24 South, Range 36 East, NMPM, Lea County, New Mexico, and (2) dedicating the spacing unit to the proposed initial Lonnie King Fed Com #212H well, to be drilled from a surface location in the SW/4 NW/4 (Unit E) of Section 30, to a bottom hole location in the NE/4 SW/4 (Unit K) of Section 18.

Matador has sought and been unable to obtain voluntary agreement for the development of these lands from all working interest owners in the subject acreage.
