Spur Energy Partners, LLC ("Spur" or "Applicant") (OGRID No. 328947) through its undersigned attorneys, hereby files this application with the Oil Conservation Division to amend Order No. R-21582 (the "Order") to allow for a one year extension for drilling the proposed initial well under the Order. In support of its application, Spur states:

1. Order No. R-21582, entered on January 19, 2021, in Case No. 21584, created a standard 200-acre horizontal spacing unit in a portion of the Yeso formation, in the Atoka; Glorieta Yeso Pool (3250) from the top of the Pool to a depth of 3,200 feet, underlying the N/2 S/2 of Section 28, and the NE/4 SE/4 of Section 29, Township 18 South, Range 26 East, NMPM, Eddy County, New Mexico (the "Unit"), and designated Applicant as the operator of the Unit.

The Unit was designated to the proposed initial (1) the Radiohead #1H well, and
(2) the Radiohead #2H well.

3. Order No. R-21582 required the drilling of the initial well by January 19, 2022.

4. There is good cause for Spur's request that the Order be re-opened and amended to allow Spur additional time to commence drilling the well under the Order.

Spur to delay its intended plans to develop the acreage subject to the Order. Spur anticipates being able to drill the initial well required by the Order within the next year.

AFFIDAVIT OF RETT DALTON

Rett Dalton, of lawful age and being first duly sworn, declares as follows:

1. My name is Rett Dalton. I am a landman for Spur Energy Partners, LLC ("Spur").

2. I have previously testified before the New Mexico Oil Conservation Division as an expert witness in petroleum land matters. My credentials as a petroleum land manager have been accepted by the Division and made a matter of record.

3. I am familiar with the application filed by Spur in this case, and I am familiar with the status of the lands in the subject area.

4. None of the pooled parties has indicated opposition to this extension application, and therefore I do not expect any opposition at the hearing.

5. Order No. R-21582, entered on January 19, 2021, in Case No. 21584, created a standard 200-acre horizontal spacing unit in a portion of the Yeso formation, in the Atoka; Glorieta Yeso Pool (3250) from the top of the Pool to a depth of 3,200 feet, underlying the N/2 S/2 of Section 28, and the NE/4 SE/4 of Section 29, Township 18 South, Range 26 East, NMPM, Eddy County, New Mexico (the "Unit"), and designated Applicant as the operator of the Unit.

6. The Unit was designated to the proposed initial (1) the Radiohead #1H well, and(2) the Radiohead #2H well.

7. Order No. R-21582 required the drilling of the initial well by January 19, 2022.

Spur anticipates being able to drill the initial well required by the Order within the next year.

10. Therefore, Spur requests a one-year extension of time to drill the initial well under the Order, until January 19, 2023.

11. Spur provided our outside counsel, Holland and Hart, with a list of the working interest owners that remain subject to each pooling order and instructed them to provide notice of this hearing to these pooled working interest owners.

12. None of the working interest owners that remain subject to these pooling orders have been asked at this time to make an election on the applicable well, or to pay their estimated share of the costs to drill, complete and equip the applicable well.
