STATEMENT OF THE CASE

Applicant applies for an order pooling all uncommitted interests within the San Andres formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 of Section 15, Township 13 South, Range 38 East, Lea County, New Mexico ("Unit"). The Unit will be dedicated the Huell Fee #5H well ("Well") to be horizontally drilled from a surface hole location in the SE/4SW/4 (Unit N) of Section 10 to a bottom hole location in the SW/4SW/4 (Unit M) of Section 15. The completed interval of the Well will be within 330' of the line

separating the W/2W/2 and E/2W/2 of Section 15 to allow for the formation of a 320-acre standard horizontal spacing unit. The completed interval of the Well will be orthodox. Also to be considered will be the cost of drilling and completing the Well and the allocation of the costs, the designation of Applicant as the operator of the Well, and a 200% charge for the risk involved in drilling and completing the Well. The Well is located approximately 13.5 miles Southeast of Tatum, New Mexico.
