In Case No. 22477, Colgate seeks an order from the Division for the limited purposes of amending Order No. R-21589 to allow for an extension of time for drilling the wells under Order No. R-21589. Colgate asks that the order extending the time for drilling be entered *nunc pro tunc* effective as of the date the Application was filed. Order R-21589 designated Colgate as the operator of the horizontal spacing unit for the drilling of Colgate’s proposed **Bolander 32 State Fed Com 121H** and **Bolander 32 State Fed Com 131H** wells, and pooled uncommitted interest owners in a 320-acre (more or less) Bone Spring non-standard horizontal spacing unit underlying

the N/2 N/2 of Section 32 and N/2 N/2 of Section 31, Township 19 South, Range 28 East, NMPM, Eddy County, New Mexico. Said area is located approximately 19 miles southeast of Artesia, New Mexico.
