**UNOPPOSED MOTION FOR CONTINUANCE

Apache Corporation ("Apache") requests the Division to (1) continue the February 3, 2022 hearing of the above-referenced competing cases and in lieu thereof hold a status conference; and (2) amend the pre-hearing order to reflect the revised hearing date for these matters. In support thereof, the Apache state:

1. In the above-referenced cases, Chisholm Energy Operating, LLC ("Chisholm") and Mewbourne Oil Company ("MOC") have opposing applications seeking orders pooling all mineral interests in the certain acreage in Lea County.

2. The Division entered an amended pre-hearing order on December 27, 2021 setting these cases for hearing on February 3, 2022.

3. Apache owns an interest in the proposed spacing units but was only recently provided notice of the MOC cases and needs additional time to evaluate its proposals and prepare for hearing.

4. Accordingly, Apache requests the February 3, 2022 hearing be vacated and the above-referenced cases be set for a status conference on February 3, 2022 and the hearing continued to a mutually convenient Division docket.

5. All parties concur in the granting of this Motion.
