**STATEMENT OF THE CASE**

These cases consist of competing applications with overlapping proposed spacing units in Sections 28, 29, 30, and 33 of Township 20 South, Range 30 East, N.M.P.M., Eddy County, New Mexico. Colgate owns an interest in acreage proposed to be pooled. North-South development as proposed by Ascent, now Matador, and by Mewbourne would strand portions of Colgate’s acreage. In addition, nearby development by standup wells has not consistently

resulted in adequate production. Laydown wells have consistently been better performers. For this reason, Colgate objects to the development plans proposed by Ascent/Matador and by Mewbourne.
