APPLICANT'S STATEMENT OF CASE

Centennial seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a standard 480-acre, more or less, horizontal spacing unit comprised of the W/2 of Section 15 and the NW/4 of Section 22, Township 20 South, Range 35 East, NMPM, Lea County, New Mexico. Centennial proposes to dedicate the above-referenced spacing unit to the proposed initial wells:

- the **Woody 22 Fed Com #501H well**, to be horizontally drilled from a surface location in the NW/4 SW/4 (Unit L) of Section 22, to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 15; and
- the **Woody 22 Fed Com #502H well**, to be horizontally drilled from a surface location in the NW/4 SW/4 (Unit L) of Section 22, to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 15.

The completed interval for the proposed **Woody 22 Fed Com #501H well** will remain within 330 feet of the quarter-quarter line separating the W/2 W/2 of Section 15 and the W/2 NW/2 of Section 22 from the E/2 W/2 of Section 15 and the E/2 NW/4 of Section 22, to allow inclusion of this acreage into a standard horizontal well spacing unit.
