In **Case No. 22365**, Applicant applies for an order pooling all uncommitted interests within the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the E/2E/2 of Section 11 and E/2SE/4 of Section 2, Township 18 South, Range 32 East, Lea County, New Mexico (“Unit”). The Unit will be dedicated to the Dragonstone 11/2 B2PI Fed Com #1 well to be horizontally drilled from a surface hole location in the NE/4NE/4 (Unit A) of Section 14 to a bottom hole location in the NE/4SE/4 (Unit I) of Section 2.

In **Case No. 22366**, Applicant applies for an order pooling all uncommitted interests within the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the E/2W/2 of Section 11 and E/2SW/4 of Section 2, Township 18 South, Range 32 East, Lea County, New Mexico (“Unit”). The Unit will be dedicated to the Dragonstone 11/2 B2NK Fed Com #1 well to be horizontally drilled from a surface hole location in the SW/4SW/4 (Unit M) of Section 11 to a bottom hole location in the NE/4SW/4 (Unit K) of Section 2.

In **Case No. 22367**, Applicant applies for an order pooling all uncommitted interests within the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the W/2W/2 of Section 11 and W/2SW/4 of Section 2, Township 18 South, Range 32 East, Lea County, New Mexico (“Unit”). The Unit will be dedicated to the Dragonstone 11/2 B2ML Fed Com #1 well to be horizontally drilled from a surface hole location in the SW/4SW/4 (Unit M) of Section 11 to a bottom hole location in the NW/4SW/4 (Unit L) of Section 2.

In **Case No. 22368**, Applicant applies for an order pooling all uncommitted interests within the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the W/2E/2 of Section 11 and W/2SE/4 of Section 2, Township 18 South, Range 32 East, Lea County, New Mexico (“Unit”). The Unit will be dedicated to the Dragonstone 11/2 B2OJ

Fed Com #1 well to be horizontally drilled from a surface hole location in the NE/4NE/4 (Unit A) of Section 14 to a bottom hole location in the NW/4SE/4 (Unit J) of Section 2.

Also to be considered in these cases will be the cost of drilling and completing the Wells and the allocation of the costs, the designation of Applicant as the operator of the Wells, and a 200% charge for the risk involved in drilling and completing the Wells. The Wells are located approximately 25 miles southwest of Carlsbad, New Mexico.
