STATEMENT OF THE CASE

APPLICANT

Case No. 22582: Mewbourne Oil Company seeks an order pooling all uncommitted mineral interest owners in the Bone Spring formation underlying a horizontal spacing unit comprised of Lot 2, SW/4NE/4, and W/2SE/4 (the W/2E/2) of Section 5, Township 22 South, Range 34 East, NMPM, and the W/2E/2 of Section 32, Township 21 South, Range 34 East, NMPM. The unit will be dedicated to (a) the Red Stag 5/32 B2OB Fed. Com. Well No. 1H, and (b) the Red Stag B3OB Fed. Com. Well No. 1H, with first take points in the SW/4SE/4 of Section 5 and last take points in the NW/4NE/4 of Section 32.

Case No. 22583: Mewbourne Oil Company seeks an order pooling all uncommitted mineral interest owners in the Bone Spring formation underlying a horizontal spacing unit comprised of Lot 1, SE/4NE/4, and E/2SE/4 (the E/2E/2) of Section 5, Township 22 South, Range 34 East, NMPM, and the E/2E/2 of Section 32, Township 21 South, Range 34 East, NMPM. The unit will be dedicated to (a) the Red Stag 5/32 B2PA Fed. Com. Well No. 1H, and (b) the Red Stag B3PA Fed. Com. Well No. 1H, with first take points in the SE/4SE/4 of Section 5 and last take points in the NE/4NE/4 of Section 32.

Also to be considered will be the cost of drilling and completing the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a cost plus 200% charge for the risk involved in drilling and completing the wells.
