SELF AFFIRMED DECLARATION OF LEE ZINK

Lee Zink hereby states and declares as follows:

- 1. I am over the age of 18, I am the Director of Land for Franklin Mountain Energy, LLC ("Franklin"), and I have personal knowledge of the matters stated herein. I have previously testified before the Oil Conservation Division ("Division") and I have been qualified by the Division as an expert petroleum landman.
- 2. My area of responsibility at Franklin includes the area of Lea County in New Mexico.
- 3. I am familiar with the applications filed by Franklin in these cases, which are attached as **Exhibit 1-A and 1-B**.
 - 4. I am familiar with the status of the lands that are subject to the applications.
- 5. I submit the following information pursuant to NMAC 19.15.4.12.A(1) in support of the above referenced compulsory pooling applications.
- 6. The purpose of the applications is to force pool only overriding royalty interests into the horizontal spacing units described below, and in the wells to be drilled in the units.
- 7. No opposition is expected because the overriding royalty interest owners being pooled have been contacted regarding the proposed wells, but have failed or refused to voluntarily commit their interests in the wells.



8. The spacing units and wells that Franklin proposes in these cases are part of a comprehensive development plan covering Sections 25 and 36, Township 24 South, Range 35 East, NMPM, Lea County, New Mexico.

9. In Case No. 22562, Franklin seeks an order from the Division pooling overriding royalty interests within a 320 acre, more or less, Bone Spring horizontal spacing unit underlying the W/2E/2 of Sections 25 and 36, Township 24 South, Range 35 East, NMPM, Lea County, New Mexico.

10. This spacing unit will be dedicated to the KC7 Fed Com 603H well to be horizontally drilled.

11. The approximate TVD for the KC7 Fed Com 603H well is 11,628' and the approximate MD is 22,311'.

12. In Case No. 22563, Franklin seeks an order from the Division pooling overriding royalty interests within a 320 acre, more or less, Bone Spring horizontal spacing unit underlying the E/2E/2 of Sections 25 and 36, Township 24 South, Range 35 East, NMPM, Lea County, New Mexico.

13. This spacing unit will be dedicated to the El Paso Fed Com 604H well to be horizontally drilled.

14. The approximate TVD for the El Paso Fed Com 604H well is 11,545' and the approximate MD is 22,161'.

15. Attached as **Exhibit 2-A and 2-B** are the proposed C-102s for the wells.

16. The C-102s identify the proposed surface hole location, the first take point, and the bottom hole location. The C-102s also identifies the pool and pool code.

17. The wells will develop the WC-025 G-09 S253502B; LWR BONE SPRING pool, pool code 98185.

18. This pool is an oil pool with 40-acre building blocks.

19. This pool is governed by the state-wide horizontal well rules. The producing interval for the wells will be orthodox and will comply with the Division's set back requirements.

20. There are no depth severances within the proposed spacing units.

21. **Exhibit 3** includes a lease tract map outlining the units being pooled. Franklin only needs to pool overriding interest owners because there are no other working interest owners within these units. Exhibit 3 also includes the overriding interest owners being pooled and a summary of the percent of their interests.

22. Because Franklin seeks only to pool overrides, Franklin was not required to send proposal letters to them, or Authorization for Expenditures. In addition, because Franklin only seeks to pool overrides, Franklin does not request any overhead or administrative rates or the imposition of a risk charge.

23. I have conducted a diligent search of the public records in the county where the well will be located, and conducted phone directory and computer searches to locate contact information for parties entitled to notification.

24. The parties Franklin is seeking to pool were notified of this hearing.

25. **Exhibit 4** is an affidavit of notice prepared by counsel for Franklin that shows the parties who were notified of this hearing, the status of whether they received notice, and an affidavit of publication from the Hobbs News-Sun newspaper, showing that notice of this hearing was published on February 6, 2022.

26. The attachments to this declaration were prepared by me, or compiled from company business records, or were prepared at my direction.

27. In my opinion, the granting of this application is in the interests of conservation and the prevention of waste.

SELF AFFIRMED DECLARATION OF BEN KESSEL

Ben Kessel hereby states and declares as follows:

1. I am over the age of 18, I am a geologist for Franklin Mountain Energy, LLC ("Franklin"), and have personal knowledge of the matters stated herein. I have previously testified before the Oil Conservation Division ("Division") and my credentials as an expert petroleum geologist were accepted by the Division as a matter of record.

2. My area of responsibility at Franklin includes the area of Lea County in New Mexico.

3. I am familiar with the applications filed by Franklin in these cases.

4. **Exhibit 5** is a locator map showing the approximate location of the proposed units in relation to the Capitan Reef.

5. **Exhibit 6** is a wellbore schematic showing Franklin's development plan, which includes the wells proposed in Case Numbers 22560 through 22565, including in this case.

6. The exhibits behind **Tab** 7 are the geology study I prepared for the El Paso Fed Com 604H and the KC7 Fed Com 603H wells, which are Third Bone Spring Sand wells, proposed in the E/2E/2 and W/2E/2 of Sections 25 and 36, Township 24 South, Range 35 East, respectively.

7. **Exhibit 7-A** is structure map of the Third Bone Spring Sand. The proposed spacing unit is identified by a pink box. The El Paso Fed Com 604H well is the black dashed line identified by the box labeled "1" and the KC7 Fed Com 603H well is the black dashed line identified by the box labeled "2". The contour interval used this exhibit is 25 feet. This exhibit shows that the structure dips gently to the southwest.

8. **Exhibit 7-B** is a cross section reference map that identifies four wells in the vicinity of the proposed wells, shown by a line of cross-section running from A to A'.

9. **Exhibit 7-C** is a stratigraphic cross section hung on the Wolfcamp top. The well logs on the cross-section give a representative sample of the Third Bone Spring formation in the area. The target zone is identified by a bracket and the words "Producing Interval". I have also identified where the proposed wells fall within the wells I used for the cross-section.

10. In my opinion, the gross interval thickness increases slightly to the west.

11. **Exhibit 7-D** is a Gross Sand Isochore of the Third Bone Spring Sand. The gross interval thickness increases slightly to the west.

- 12. I conclude from the maps that:
 - a. The horizontal spacing units are justified from a geologic standpoint.
 - b. There are no structural impediments or faulting that will interfere with horizontal development.
 - c. Each quarter quarter section in the proposed units will contribute more or less equally to production.

13. Exhibit 8 provides an overview of the stress orientation in the area based on the2018 Snee-Zoback paper.

14. The preferred well orientation in this area is either north/south or south/north, nearly orthogonal to S_{Hmax} , optimal for inducted fracture propagation. This is because the S_{Hmax} is at approximately 265 degrees ENE in this area of Lea County.








- Black box shows the location of FMM development area
- Planned wells are located inside of the western edge of the Capitan Reef




Wellbore Schematic



Bone Spring Structure




