**UNOPPOSED MOTION TO VACATE THE MARCH 17, 2022 HEARING, TO VACATE  
THE AMENDED PRE-HEARING ORDER AND DEADLINES, AND  
FOR CONTINUANCE TO APRIL 21, 2022**

Marathon Oil Permian LLC (“Marathon”) submits this motion to (1) vacate the contested hearing currently set for March 17, 2022; (2) vacate the Amended Pre-hearing order and deadlines, and (3) request a continuance of these cases to the April 21, 2022 docket.

1. Titus Oil & Gas Production, LLC (“Titus”) had applications that competed with the above captioned Marathon cases. The Titus cases and Marathon cases are currently set for a contested hearing on March 17, 2022; however, Titus recently moved to dismiss its competing cases, and, on March 2, 2022, the Oil Conservation Division dismissed those cases.

2. As a result of Titus’ dismissal of its competing cases, there is no need for a contested hearing on March 17, 2022.

3. Thus, Marathon requests that the March 17, 2022 hearing be vacated along with all associated deadlines.

4. Marathon also requests that the Marathon cases be continued to April 21, 2022.

5. Titus does not object to the relief sought in this motion.

6. Chevron U.S.A., Inc., the other party to these cases, withdrew its entry of appearance on March 7, 2022.

7. For the foregoing reasons, Marathon respectfully requests the Division (1) vacate the contested hearing currently set for the March 17, 2022 docket, (2) vacate the associated pre-hearing order and deadlines, and (3) continue the above captioned Marathon cases to April 21, 2022.
