**CIMAREX'S RESPONSE TO DEVON'S
MOTION TO STRIKE EXHIBITS AND TESTIMONY**

Cimarex Energy Co. ("Cimarex"), by counsel, submits this Response to Devon Energy Production Company, L.P.'s ("Devon") Motion to Strike Exhibits and Testimony (the "Motion"). In essence, Devon seeks to exclude certain testimony and exhibits prepared by Cimarex's reservoir engineer—Eddie Behm—based on an asserted lack of foundation. *See* Motion ¶¶ 2, 4. However, the Motion is little more than a frivolous attempt by Devon to distract from the issues presented in this case. The Motion is contrary to the rules of the Division which liberally permit parties a full opportunity to present evidence supporting their case. Therefore, the Motion should be denied.

1. Devon's Motion should be denied for three reasons: (1) as an expert reservoir engineer, Mr. Behm may state an opinion without first testifying to the underlying facts and data supporting that opinion; (2) the exhibits sought to be excluded are admissible summaries of voluminous well data; and (3) Cimarex is producing herewith the underlying information supporting the testimony and the exhibits sought to be excluded.

2. Under the Division's rules, the Division "shall afford *full opportunity* to the parties at an adjudicatory hearing . . . to present evidence . . ." Rule 19.15.4.17(A) NMAC

(emphasis added). While the New Mexico Rules of Evidence do not apply to Division hearings, the Division “may use such rules as guidance in conducting adjudicatory hearings.” *Id.* Here, the Rules of Evidence provide relevant guidance in favor of denying the Motion.

3. The Rules of Evidence demonstrate that an expert, such as Mr. Behm, is not required to identify or provide all of the underlying facts supporting his opinions before making them. Instead, Rule 11-703 NMRA provides that an expert may base an opinion on facts or data in the case that the expert has been made aware of or personally observed.” Moreover, and as critical here, “an expert may state an opinion – and give the reasons for it – *without* first testifying to the underlying facts or data.” Rule 11-705 NMRA (emphasis added). Accordingly, under the Rules of Evidence and Division practice, Mr. Behm should be allowed to testify regarding his opinion of Devon’s poor well performance based on his personal review of the well data without individually identifying each of the hundreds of wells included in the data he analyzed.

4. Just because the Rules of Evidence do not require Mr. Behm to provide the full factual data set underlying his opinions in advance does not mean that the foundation for his opinion cannot be tested. Rather, Devon’s opportunity to test the basis of Mr. Behm’s testimony and exhibits should take the form of cross-examination at the hearing. *See* Rule 19.15.4.17(A) NMAC (allowing parties “full opportunity” to “cross-examine witnesses”); *see also, e.g., Jaramillo v. Fisher Controls Co., Inc.*, 1985-NMCA-008, ¶ 50, 102 N.M. 614, 698 P.2d 887 (explaining that the Rules of Evidence expressly authorize the testing of the basis of an expert’s opinion by cross-examination). Here, to the extent that Devon feels that Mr. Behm’s testimony or exhibits were not adequately supported by underlying data, the proper recourse is to raise that issue in cross-examination at the hearing rather than wasting the Division’s and Cimarex’s resources and time by filing this frivolous Motion.

5. Second, the Rules of Evidence specifically allow an expert to testify and offer demonstrative exhibits illustrating the expert's opinion without being required to produce all of the data reviewed. Rule 11-1006 NMRA provides:

The proponent may use a summary, chart, or calculation to prove the content of voluminous writings, recordings, or photographs that cannot be conveniently examined in court. The proponent must make the originals or duplicates available for examination or copying, or both, by other parties at a reasonable time and place. The court may order the proponent to produce them in court.

6. Here, the exhibits sought to be excluded (Cimarex Exhibits D-13 through D-15-B) each summarize voluminous well data reviewed by Mr. Behm. In preparing these exhibits, Mr. Behm compiled data from more than 750 active wells in Lea County. As Mr. Behm explained in his affidavit, the purpose of these exhibits is to demonstrate the relative underperformance of Devon's wells as compared to those of other operators in the area and to Cimarex. *See* Cimarex Ex. D, Behm Aff. ¶¶ 34-36. Significantly, and ignored by Devon, Mr. Behm's testimony qualitatively identifies the well set he used to create Exhibits D-13 to D-15-B.

7. Mr. Behm's testimony and exhibits properly summarize publically-available production data from roughly 769 wells is consistent with Rule 11-1006. Additionally, to the extent it is necessary, Mr. Behm can further lay the foundation for these exhibits at the hearing itself. *See, e.g., United States v. Behrens*, 689 F.2d 154, 161 (10th Cir. 1982) ("A proper foundation for such a summary can be laid through the testimony of the witness who supervised preparation of the exhibit."). Furthermore, as a show of good faith and, treating Devon's Motion as a request for such information pursuant to Rule 11-1006, Cimarex is producing with this response a list of the wells used by Mr. Behm for his direct and anticipated rebuttal testimony and exhibits and Dos Equis well production data. *See* Ex. 1 and 2 respectively.

8. Contrary to Devon's contention in the Motion, it has not been unduly prejudiced by any failure of Cimarex to identify the wells used in creating these exhibits because (1) Cimarex is producing the well information herewith; and (2) Devon can cross-examine Mr. Behm regarding the facts underlying his opinions. *See, e.g., Edwards v. Sears, Roebuck & Co.*, 512 F.2d 276, 294 (5th Cir. 1975) ("An expert's references to records and material without their admission in evidence are permissible where thorough cross-examination is afforded and the records in question are readily available for inspection by the other parties."); *United States v. Jamieson*, 427 F.3d 394, 411 (6th Cir. 2005) (explaining that a party did not suffer prejudice based on failure to provide access to documents in a timely manner where the opposing party could still conduct cross-examination of the witness who prepared the summaries).

9. Moreover, the exhibits themselves demonstrate the purpose for which they were created and thus, there is no reason that Devon could not fully prepare for the hearing based on what has already be submitted. As discussed above, the Exhibits themselves identify the data set Mr. Behm used. Put simply, Devon's ability to challenge the propositions expressed by these exhibits was not inhibited by the alleged lack of foundational data, such as well names. Also, since Cimarex is producing that information now, Devon cannot argue that it is has suffered any prejudice by Cimarex's decision not to include the voluminous supporting data with its original exhibit packet.

10. Finally, it should be noted that Devon's exhibit packet included numerous exhibits which lacked foundational data and for which, according to Devon's own logic, are inadmissible. For example, Devon Exhibit No. C5 entitled "AFE Comparison" does not include any data to support the information included in the column titled "Devon Gross Type Costs." The dollar amounts included in this column do not match Devon's submitted AFEs or any other source data

included with Devon's exhibits. Nor is there any explanation or methodology included to show how Devon arrived at these figures. In his testimony, Devon's petroleum engineer, Karsan Sprague, simply stated that "Devon's costs for 2-mile wells are \$1,200,000 lower per well than what Cimarex has proposed." See Devon Ex. C, Sprague Aff. ¶ 11. Another example is the testimony of Devon's geologist, Thomas Peryam, where he relied exclusively on academic papers that are available only through subscription services and that Devon did not provide with its testimony. See Devon Ex. B, Peryam Aff. ¶ 13 n.1, n.2. Despite these deficiencies Cimarex did not try and waste the Division's time and the parties' resources by moving to strike these exhibits. Instead, Cimarex intends to proceed as contemplated by the Rules of Evidence and Division practice which is to test Devon's testimony and exhibits through cross-examination and, if found lacking, seek to exclude them at that time.

11. In conclusion, Devon's Motion misses the mark because Mr. Behm's testimony and exhibits are exactly the type of admissible evidence contemplated by the Rules of Evidence. Moreover, Cimarex has provided the identifying well information to support the opinions reached by Mr. Behm. Lastly, as Devon is free to cross-examine Mr. Behm regarding the facts underlying his opinions and exhibits, it has not suffered any prejudice. Accordingly, the Motion should be denied.
