APPLICANT'S STATEMENT OF CASE

In Case No. 22460, COG seeks an order pooling all uncommitted interests in a portion of the Bone Spring formation, from a depth of 10,000 feet to the base of the Bone Spring formation, underlying a standard 639.87-acre, more or less, horizontal spacing unit comprised of Lots 3 & 4, S/2 NW/4, SW/4 (W/2 equivalent) of Section 5, Township 24 South. Range 32 East and the W/2 of Section 32, Township 23 South, Range 32 East, N.M.P.M., Lea County, New Mexico. The spacing unit will be dedicated to the following proposed initial wells: the Gin and Tectonic Federal Com #504H well, to be drilled from a surface hole location in SE/4 SW/4 (Unit N) of Section 5 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 32; and the Gin and Tectonic Federal Com #505H well and the Gin and Tectonic Federal Com #506H well, both of which will be drilled from a surface location in SW/4 SW/4 (Unit M) of Section 5 to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 32. The completed interval for the proposed Gin and Tectonic Federal Com #505H well will be within 330 feet of the line separating the E/2 W/2 and W/2 W/2 to allow inclusion of this acreage in the spacing unit. A depth severance exists in the Bone Spring formation within the proposed the horizontal spacing unit. As such, COG seeks to pool only a portion of the Bone Spring formation, from a depth of 10,000 feet, to the base of the Bone Spring formation, as defined in the Assignment of Undivided Interest in Oil and Gas, dated March 1, 1996, that covers the SE/4 NW/4 of Section 32, Township 23 South, Range 32 East, and in the Gamma Ray-Neutron Log of the Falcon 32 State #001H Well (API No. 30-025-33001).

In **Case No. 22461**, COG seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a standard 639.13-acre, more or less, horizontal spacing unit comprised of Lots 1 & 2, S/2 NE/4, SE/4 (E/2 equivalent) of Section 5, Township 24 South, Range 32 East, and the E/2 of Section 32, Township 23 South. Range 32 East, N.M.P.M., Lea County, New Mexico.

The completed interval for the proposed Gin and Tectonic Federal **Com #702H well** will be within 330 feet of the line separating the E/2 E/2 and W/2 E/2 to allow inclusion of this acreage in the spacing unit.
