APPLICANT'S STATEMENT OF CASE

In **Case No. 22687**, Centennial seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a standard 640-acre, more or less, horizontal spacing unit comprised of the W/2 of irregular Sections 6 and 31, Township 22 South, Range 35 East, NMPM, Lea County, New Mexico. The spacing unit will be dedicated to the proposed initial (1) Eric Cartman 6 State Com #601H well, to be horizontally drilled from a surface location in the SW/4 SW/4 (Lot 7) of irregular Section 6, to a bottom hole location in the NW/4 NW/4 (Lot 1) of irregular Section 31; (2) the Eric Cartman 6 State Com #602H well, to be horizontally drilled

from a surface location in the SW/4 SW/4 (Lot 7) of irregular Section 6, to a bottom hole location in the NE/4 NW/4 (Unit C) of irregular Section 31; and (3) the **Eric Cartman 6 State Com #603H well**, to be horizontally drilled from a surface location in the SW/4 SE/4 (Unit O) of irregular Section 6, to a bottom hole location in the NE/4 NW/4 (Unit C) of irregular Section 31. The completed interval for the proposed **Eric Cartman 6 State Com #602H** well will remain within 330 feet of the quarter-quarter line separating the E/2 W/2 from the W/2 W/2 of irregular Sections 6 and 31, to allow inclusion of this acreage into a standard horizontal well spacing unit.

In **Case No. 22688**, Centennial seeks an order (1) approving a standard 640-acre, more or less, horizontal spacing unit in a portion of the Bone Spring formation from a depth of 10,388 feet to the base of the Bone Spring formation, comprised of the E/2 of irregular Sections 6 and 31, Township 22 South, Range 35 East, NMPM, Lea County, New Mexico; and (2) pooling all uncommitted interests within such acreage. The proposed spacing unit will be dedicated to the initial (1) **Eric Cartman 6 State Com #604H well**, to be horizontally drilled from a surface location in the SW/4 SE/4 (Unit O) of irregular Section 6, to a bottom hole location in the NW/4 NE/4 (Unit B) of irregular Section 31; and (2) the **Eric Cartman 6 State Com #605H well**, to be horizontally drilled from a surface location in the SW/4 SE/4 (Unit O) of irregular Section 31; and (2) the **Eric Cartman 6 State Com #605H well**, to be horizontally drilled from a surface location in the SW/4 SE/4 (Unit O) of irregular Section 31; and (2) the **Eric Cartman 6 State Com #605H well**, to be horizontally drilled from a surface location in the SW/4 SE/4 (Unit O) of irregular Section 31; and (2) the **Eric Cartman 6 State Com #605H well**, to be horizontally drilled from a surface location in the SW/4 SE/4 (Unit O) of irregular Section 31. The completed interval for the proposed **Eric Cartman 6 State Com #604H well** will remain within 330 feet of the quarter-quarter line separating the W/2 E/2 from the E/2 E/2 of irregular Sections 6 and 31, to allow inclusion of this acreage into a standard horizontal well spacing unit.
