APPLICANT’S STATEMENT OF THE CASE

In these consolidated cases, Fasken seeks orders pooling all uncommitted interests in the Bone Spring formation underlying standard 320-acre spacing units in the W/2 of Sections 22 and 15, Township 20 South, Range 32 East, NMPM, Lea County, as follows:

- Under **Case 22697**, Fasken seeks to pool the Bone Spring formation underlying the W/2 W/2 of Sections 22 and 15 for the proposed **Baetz 22/15 Fed Com 1H** well to be drilled from a surface location in the SW/4 SW/4 (Unit M) of Section 22 to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 15.
- Under **Case 22698**, Fasken seeks to pool the Bone Spring formation underlying the E/2 W/2 of Sections 22 and 15 for the proposed **Baetz 22/15 Fed Com 2H** well to be drilled from a surface location in the SW/4 SW/4 (Unit M) of Section 22 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 15.

Fasken has sought but been unable to obtain voluntary agreement for the development of these lands from all mineral interest owners in the subject acreage.
