**APPLICANT'S STATEMENT OF THE CASE**

In this case, Matador seeks orders pooling all uncommitted interests in the Bone Spring formation underlying a standard 240-acre, more or less, horizontal spacing unit comprised of the S/2 S/2 of Section 12, and the S/2 SE/4 of Section 11, Township 21 South, Range 27 East, Eddy County, New Mexico. Matador intends to dedicate the spacing unit to the proposed initial **Bo Howard 1211 Fed Com #124H well**, to be drilled from a surface location in the SE/4 SE/4 (Unit

P) of Section 12, to a bottom hole location in the SW/4 SE/4 (Unit O) of Section 11. The completed interval of the well will comply with statewide setbacks for oil wells.
