**AFFIDAVIT OF LANDMAN MITCH KRAKAUSKAS**

I, Mitch Krakauskas, being duly sworn on oath, state the following:

1. I am over the age of 18, and have the capacity to execute this affidavit, which is based on my personal knowledge.

2. This affidavit is a supplement to my previous affidavit submitted in the above-referenced cases, which were heard by the New Mexico Oil Conservation Division on April 7, 2022. It is submitted at the request of the hearing examiners at that hearing.

3. Attached hereto as Exhibit 5 is a chronology of contacts with the overriding royalty owners sought to be pooled in this case.

4. Attached hereto as Exhibit 6 is a list of overriding royalty owners sought to be pooled and a list of royalty owners without pooling clauses, whom Applicant seeks to pool pursuant to 19.15.4.12(A)(1) NMAC. The State Land Office and the Bureau of Land Management were notified as affected persons pursuant to 19.15.4.12(A)(1) NMAC (referring to affected persons in the context of compulsory pooling applications) and 19.15.2.7(A)(8)(d) NMAC (defining “affected persons”). *See also* 19.15.4.9(A)(6) NMAC (stating that the adjudicatory hearing shall include “a reasonable identification of the adjudication’s subject matter *that alerts persons who may be affected* if the division grants the application” (emphasis added)).

5. Previously, Applicant inadvertently included the State of New Mexico, Taxation & Revenue Department (“NMTRD”) as a party to be noticed because the address was used to submit funds to the State. Notification to NMTRD was unnecessary because it has no interest in the minerals. The correct party to be notified on behalf of the State is the State Land Office, which was duly noticed.

6. The foregoing is correct and complete to the best of my knowledge and belief.
