Cimarex mailed letter notice to Colgate on 2/9/22 (see certified receipt of mailing). Confirmation of Colgate's receipt of notice was received by Cimarex's receipt of the returned green card. Green cards are periodically returned without signature, as confirmed by testimony of Colgate in the cases, pointing out that green cards are periodically received unsigned and in various other conditions. Colgate made an appearance in the cases and did not challenge the notice by letter or object on the basis that it was not received. It has also been counsel's experience with the USPS that the in transit status is periodically not updated to delivery status after the return of the green card. This has recently occurred in Cases 22586-91 in which a signed green card was returned but the USPS did not update the in transit status to delivered. Cimarex appreciates the opportunity to provide this revised mailing report for the OCD's consideration.
