**APPLICATION OF COLGATE OPERATING, LLC  
FOR COMPULSORY POOLING,  
LEA COUNTY, NEW MEXICO.**

**APPLICATION**

Pursuant to NMSA § 70-2-17, Colgate Operating, LLC (“Applicant”) (OGRID No. 371449) applies for an order pooling all uncommitted interests within the Bone Spring and Harkey formations underlying a 320.32-acre, more or less, standard horizontal spacing unit comprised of Lots 1, 2, 3, and 4 (W/2 W/2 equivalent) of irregular Sections 18 and 19, Township 20 South, Range 34 East, Lea County, New Mexico (“Unit”). In support of its application, Applicant states the following.

1. Applicant is a working interest owner in the Unit and has the right to drill wells thereon.
2. The Unit will be dedicated to the following wells (“Wells”):
  - a. **Batman Fed Com 111H** to be horizontally drilled from a surface hole location in the NE/4 NW/4 (Unit C) of Section 18 to a bottom hole location in the SW/4 SW/4 (Lot 4) of Section 19;
  - b. **Batman Fed Com 121H** to be horizontally drilled from a surface hole location in the NE/4 NW/4 (Unit C) of Section 18 to a bottom hole location in the SW/4 SW/4 (Lot 4) of Section 19;
  - c. **Batman Fed Com 122H** to be horizontally drilled from a surface hole location in the NE/4 NW/4 (Unit C) of Section 18 to a bottom hole location in the SW/4 SW/4 (Lot 4) of Section 19;

- d. **Batman Fed Com 171H** to be horizontally drilled from a surface hole location in the NE/4 NW/4 (Unit C) of Section 18 to a bottom hole location in the SW/4 SW/4 (Lot 4) of Section 19; and
  - e. **Batman Fed Com 131H** to be horizontally drilled from a surface hole location in the NE/4 NW/4 (Unit C) of Section 18 to a bottom hole location in the SW/4 SW/4 (Lot 4) of Section 19.
3. The completed intervals of the Wells will be orthodox.
  4. Applicant has undertaken diligent, good-faith efforts to obtain voluntary agreements from all interest owners to participate in the drilling of the Wells but has been unable to obtain voluntary agreements from all interest owners.
  5. The pooling of uncommitted interests will avoid the drilling of unnecessary wells, prevent waste, and protect correlative rights.
  6. In order to allow Applicant to obtain its just and fair share of the oil and gas underlying the subject lands, all uncommitted mineral interests in the Unit should be pooled and Applicant should be designated the operator of the Wells and Unit.

WHEREFORE, Applicant requests this application be set for hearing on June 2, 2022, and that after notice and hearing, the Division enter an order:

- A. Pooling all uncommitted interests in the Unit;
- B. Approving the Wells in the Unit;
- C. Designating Applicant as operator of the Unit and the Wells to be drilled thereon;
- D. Authorizing Applicant to recover its costs of drilling, equipping and completing the Wells;

- E. Approving the actual operating charges and costs of supervision while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and
- F. Imposing a 200% penalty for the risk assumed by Applicant in drilling and completing the Wells against any working interest owner who does not voluntarily participate in the drilling of the Wells.
