STATEMENT OF THE CASE

Applicant applies for an order pooling all uncommitted mineral interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit (“Unit”) comprised of the E/2W/2 of Sections 8 and 17, Township 19 South, Range 35 East, Lea County, New Mexico. The Unit will be dedicated to the Rambo E2W2 08-17 B1 1H well (“Well”) which will be horizontally drilled from a surface location in the NE/4NW/4 (Unit C) of Section 8 to a bottom hole location in the SE/4SW/4 (Unit N) of Section 17. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost, the designation of Applicant as the operator of the Well, and a 200% charge for the risk involved in drilling and completing the Well. The Well is located approximately 20 miles west of Hobbs, New Mexico.
