
**UNOPPOSED MOTION TO VACATE PRE-HEARING ORDER  
AND  
SET A STATUS CONFERENCE**

Mewbourne Oil Company (“Mewbourne”) moves the Division to vacate the Pre-Hearing Order (“PHO”) entered in Case Nos. 22427 and 22428 on February 17, 2022. In support thereof, Mewbourne states:

1. Pursuant to the PHO, Case Nos. 22427 and 22428 are set for the May 5<sup>th</sup> docket.
2. Subsequent to entry of the PHO, Mewbourne Case Nos. 22721 and 22722, and Colgate Operating, LLC Case Nos. 22702-22705, were filed. The cases collectively cover the same lands and formation.
3. All cases should be consolidated for hearing. Therefore, Mewbourne requests that the PHO be vacated, and the cases be scheduled for a status conference on May 5<sup>th</sup>.
4. No one objects to this motion.
