**STATEMENT OF THE CASE**

In **Case No. 22736**, Spur seeks an order pooling additional interest owners under the terms of Order No. R-22049. On February 23, 2022, the Division issued Order No. R-22049 in Case No.

22475, which pooled uncommitted interests from a depth of approximately 4,000' to the base of the Yeso Formation (Artesia; Glorieta-Yeso Pool, Code 96830) in a 160-acre, more or less, standard horizontal spacing unit ("Unit"), comprised of the S/2 S/2 of Section 27, Township 17 South, Range 28 East in Eddy County, New Mexico. Order No. R-22049 dedicated the Unit to the Halberd 27 State Com 72H and Halberd 27 State Com 90H wells and designated Applicant as operator of the Unit and the wells. Since the Order was entered, Spur has identified additional interest owners in the Unit that should be pooled under the terms of the Order.

In **Case No. 22737**, Spur seeks an order pooling additional interest owners under the terms of Order No. R-22060. On March 9, 2022, the Division issued Order No. R-22060 in Case No. 22532, which pooled uncommitted interests from a depth of approximately 4,000' to the base of the Yeso formation (Artesia; Glorieta-Yeso Pool, Code 96830) in a 320-acre, more or less, Unit comprised of the N/2 S/2 and S/2 N/2 of Section 27, Township 17 South, Range 28 East in Eddy County, New Mexico. The Order dedicated the Unit to the Halberd 27 State Com 50H well, Halberd State Com 51H well, and Halberd 27 State Com 71H wells and designated Applicant as the operator of the Unit and the wells. Since the Order was entered, Spur has identified additional interest owners in the Unit that should be pooled under the terms of the Order.

In **Case No. 22738**, Spur seeks an order pooling additional interest owners under the terms of Order No. R-22062. On March 9, 2022, the Division issued Order No. R-22062 in Case No. 22533, which pooled uncommitted interests from the top of the Yeso formation to a depth of approximately 4,000' (Artesia; Glorieta-Yeso Pool, Code 96830) in a 160-acre, more or less, Unit comprised of the N/2 S/2 of Section 27, Township 17 South, Range 28 East in Eddy County, New Mexico. The Order dedicated the Unit to the Halberd 27 State Com 21 H well and designated Spur

as operator of the Unit and the well. Since the Order was entered, Spur has identified additional interest owners in the Unit that should be pooled under the terms of the Order.

The Wells are located approximately 10 miles west of Loco Hills, New Mexico.
