
**MOTION TO VACATE PRE-HEARING ORDER  
AND  
MOTION FOR A CONTINUANCE**

Mewbourne Oil Company (“Mewbourne”) moves the Division to vacate the Pre-Hearing Order (“PHO”) entered in these cases, and to continue the scheduled hearing. In support thereof, Mewbourne states:

1. These competing pooling cases are set for hearing on the May 19<sup>th</sup> docket pursuant to the PHO.
2. The interests of Chisholm Energy Operating, LLC are now owned or operated by Earthstone Operating, which desires additional time to review the matter. It will also allow the parties additional time to discuss their differences.
3. Mewbourne requests that the PHO be vacated and the cases be continued to July 7<sup>th</sup>.
4. This motion is unopposed by the applicants, Apache Corporation, and EOG Resources, Inc. The undersigned has not yet heard from counsel for COG Operating LLC.

WHEREFORE, Mewbourne requests that the PHO and the contested hearing be vacated, and that the cases be continued to July 7<sup>th</sup>.


