**MOTION FOR TO AMEND THE PRE-HEARING ORDER**

COG Operating LLC (“COG”) moves to further amend the Pre-Hearing Order, dated April 8, 2022 (“Pre-Hearing Order”). The Pre-Hearing Order was first amended to consolidate the above-referenced cases on April 26, 2022. COG moves the Division to further amend the Pre-Hearing Order to continue the contested hearing in these matters until the July 7, 2022, hearing docket. In support, COG states:

1. These cases are set for a contested hearing on June 2, 2022, under the Pre-Hearing Order.
2. COG and Mewbourne have been engaged in negotiations to resolve these contested matters. Negotiations could result in a settlement which would mean that the cases would be uncontested.
3. COG anticipates that efforts to reach voluntary agreement will accelerate in the coming weeks; however, the parties require additional time to discuss a potential resolution.
4. COG has conferred with Mewbourne and Mewbourne does not oppose this motion.

WHEREFORE, COG requests that the Pre-Hearing Order in these matters be amended to continue the contested hearing in these matters until the July 7, 2022, hearing docket.
