APPLICANT’S STATEMENT OF CASE

In these consolidated cases, Mewbourne seeks orders pooling all uncommitted interests in the Bone Spring formation [Antelope Ridge; Bone Spring Pool (2200)] underlying the W2 of Sections 26 and 35, Township 23 South, Range 41 East, NMPM, Lea County, New Mexico as follows:

- Under **Case 22806**, Mewbourne seeks to pool a 320-acre standard horizontal well spacing unit comprised of E2W2 of Sections 26 and 35 to be initially dedicated to the proposed **Mad Dog 26/35 B2CN State Com 1H** well to be horizontally drilled from a surface location in the NW4NW4 (Unit D) of Section 26 to a bottom hole location in the SE4SW4 (Unit N) of Section 35.
- Under **Case 22807**, Mewbourne seeks to pool a 320-acre standard horizontal well spacing unit comprised of W2W2 of Sections 26 and 35 to be initially dedicated to the proposed **Mad Dog 26/35 B1DM State Com 1H**, the **Mad Dog 26/35 B2DM State Com 1H** and the **Mad Dog 26/35 H3DM State Com 1H** wells to be horizontally drilled from a surface location in the NW4NW4 (Unit D) of Section 26 to bottom hole locations in the SW4SW4 (Unit M) of Section 35.

Mewbourne has sought but been unable to obtain voluntary agreement for the development of these lands from all mineral interest owners in the subject acreage.
