STATEMENT OF THE CASE

In **Case No. 22811**, Applicant applies for an order pooling all uncommitted interests in the Pennsylvanian Shale Formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Section 18 and the E/2 NW/4 of Section 19, Township 17 South, Range 36 East, Lea County, New Mexico. The unit will be dedicated to the **Bluebell 22115 19-18 State Com #1H** well to be horizontally drilled from a surface hole location in the NE/4 SW/4 (Unit K) of Section 19 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 18. In **Case No. 22812**, Applicant applies for an order pooling all uncommitted interests in the Pennsylvanian Shale Formation underlying a 223.81-acre, more or less, standard horizontal spacing unit comprised of Lots 1, 2, 3 and 4 (W/2 W/2 equivalent) of irregular Section 18 and Lots 1 and 2 (W/2 NW/4 equivalent) of irregular Section 19, Township 17 South, Range 36 East, Lea County, New Mexico. The unit will be dedicated to the **Bluebell 22115 19-18 State Com #2H** well to be horizontally drilled from a surface hole location in the NE/4 SW/4 (Unit K) of Section 19 to a bottom hole location in Lot 1 (NW/4 NW/4 equivalent) of irregular Section 18.

Also to be considered will be the cost of drilling and completing the wells and the allocation of the cost, the designation of Applicant as the operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells. The wells are located approximately 8 miles south of Lovington, New Mexico.
