MOTION TO VACATE PRE-HEARING ORDER

Spur Energy Partners LLC (“Spur”) moves to vacate the Pre-Hearing Order in these cases. In support, Spur states:

1. Jalapeno Corporation (“Jalapeno”) filed a notice withdrawing its objection to these cases proceeding by affidavit. Moreover, Spur has reached agreement with Jalapeno to exclude Jalapeno’s interests from these compulsory pooling proceedings. It is no longer a party subject to force pooling.

2. In addition, Spur has reached separate agreements with Apache Corporation and Contango Oil & Gas Company that resolve their separate objections to Spur’s applications in these cases.

3. Counsel for Apache Corporation concurs in this motion and confirmed that the company does not object to these matters proceeding to hearing by affidavit.

4. Counsel for Contango Oil & Gas Company concurs in this motion and filed a formal withdrawal of its objection to these matters proceeding to hearing by affidavit.

5. Having resolved the objections of all parties to these matters proceeding to hearing by affidavit, Spur requests that the Examiner vacate the Pre-Hearing Order and that these cases

proceed to hearing by affidavit under the standard Division deadlines for filing testimony and exhibits.

WHEREFORE, for the reasons stated, Spur respectfully requests that its motion be granted.
