STATEMENT OF THE CASE

APPLICANT

Mewbourne Oil Company seeks an order pooling all mineral interests in the Wolfcamp formation underlying a horizontal spacing unit comprised of the NE/4 of Section 22 and the E/2 of Section 15, Township 25 South, Range 28 East, NMPM. The unit will be dedicated to the Bonanza 22/15 W0GB Fed. Com. Well No. 1H, Bonanza 22/15 W1GB Fed. Com. Well No. 2H, Bonanza 22/15 W0HA Fed. Com. Well No. 1H, and Bonanza 22/15 W1HA Fed. Com. Well No. 2H. The wells have first take points in the S/2NE/4 of Section 22, and last take points in the N/2NE/4 of Section 15. Also to be considered will be the cost of drilling, completing, and equipping the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling, completing, and equipping the wells.


