1. Applicant is an interest owner in the N $\frac{1}{2}$ N $\frac{1}{2}$ of Section 11 and the N $\frac{1}{2}$ NW $\frac{1}{4}$ of Section 12, and has the right to drill a well thereon.
2. Applicant proposes to drill the Sapphire 11/12 B3DC State Com. Well No. 2H to a depth sufficient to test the Bone Spring formation, and dedicate the N $\frac{1}{2}$ N $\frac{1}{2}$ of Section 11 and the N $\frac{1}{2}$ NW $\frac{1}{4}$ of Section 12 to the well. The well is a horizontal well, a first take point in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 11 and a last take point in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 12.


