STATEMENT OF THE CASE

In Case No. 22824, Applicant applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Sections 3 and 4, Township 20 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the Dundee 4 Fed Com 202H well, to be horizontally

drilled from a surface hole location in the NE/4 SE/4 (Unit I) of Section 5 to a bottom hole location in the NE/4 SE/4 (Unit I) of Section 3. The completed interval of the Well will be orthodox.

In **Case No. 22825**, Applicant applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 S/2 of Sections 3 and 4, Township 20 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the Dundee 4 Fed Com 203H well, to be horizontally drilled from a surface hole location in the NE/4 SE/4 (Unit I) of Section 5 to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 3. The completed interval of the Well will be orthodox.

In **Case No. 22826**, Applicant applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Sections 3 and 4, Township 20 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the Dundee 4 Fed Com 201H well, to be horizontally drilled from a surface hole location in the NE/4 NE/4 (Lot 1) of Section 5 to a bottom hole location in the SE/4 NE/4 (Unit H) of Section 3. The completed interval of the Well will be orthodox.

Also to be considered in each case will be the cost of drilling and completing the Wells and the allocation of the costs, the designation of Applicant as the operator of the Wells, and a 200% charge for the risk involved in drilling and completing the Wells. The Wells are located approximately 12 miles northeast of Carlsbad, New Mexico.
