**STATEMENT OF THE CASE**

Colgate seeks an order pooling additional uncommitted interests under the terms of Order No. R-21226. On September 25, 2020, the Division entered Order No. R-21354-A (“Order”) in Case No. 21226, which pooled all uncommitted interests in the Winchester, Bone Spring Pool (Code 65010) within the Bone Spring formation underlying a horizontal spacing unit comprised of the S/2 of Sections 33 and 34, Township 19 South, Range 28 East, Eddy County, New Mexico

(“Unit”). The Order further dedicated the Unit to the Dawson 34 Fed State Com 123H, Dawson 34 Fed State Com 133H, Dawson Fed State Com 124H, and Dawson 34 Fed State Com 134H wells (“Wells”) and designated Applicant as operator of the Unit and Wells. Since the Order was entered, Colgate has identified additional uncommitted interests in the Unit that should be pooled under the terms of the Order.

The Wells are located approximately 12 miles northeast of Carlsbad, New Mexico.
