STATEMENT OF THE CASE

APPLICANT

Case No. 22648: Mewbourne Oil Company seeks an order pooling all uncommitted mineral interest owners in the Bone Spring formation underlying a horizontal spacing unit comprised of the S/2SE/4 of Section 28 and the S/2S/2 of Section 27, Township 20 South, Range 27 East, NMPM. The unit will be dedicated to the Nina 28/27 B3OP Fed. Com. Well No. 1H, a horizontal well with a first take point in the SW/4SE/4 of Section 28 and a last take point in the SE/4SE/4 of Section 27.

Case No. 22672: Mewbourne Oil Company seeks an order pooling all uncommitted mineral interest owners in the Bone Spring formation underlying a horizontal spacing unit comprised of the S/2SW/4 of Section 28 and the S/2S/2 of Section 29, Township 20 South, Range 27 East, NMPM. The unit will be dedicated to the Pinta 28/29 B3NM Fed. Com. Well No. 1H, a

horizontal well with a first take point in the SE/4SW/4 of Section 28 and a last take point in the SW/4SW/4 of Section 29.

Also to be considered will be the cost of drilling, completing, and equipping the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling, completing, and equipping the well.


